Terms and Conditions

Objective:

- To provide service and/or rental of specialized IMCD equipment. This program enables landowners to demonstrate and utilize specialized equipment not readily in the area for conservation projects.

Eligibility and Conditions:

- Project site must be within the Intermountain Conservation District.
- The landowner or participant must be in good financial standing with the IMCD.
- Use is defined as 48 hours from the time of pick-up or delivery
- Payment for equipment or service is required at time of pickup.
- Services will be subject to the availability of staff. IMCD shall determine application priority in consultations with sub-district, Board and staff
- Equipment picked up at returned to the IMCD yardsite at Ethelbert will not incur any delivery, pick-up, or set-up charges.
- Rental fee plus GST and a \$100 damage deposit is required at the time of pick-up or delivery of equipment.
- The renter will be responsible for repairs needed after usage of equipment in excess of the \$100 damage deposit.
- IMCD reserves the right to access the site for inspection and to promote our programs.
- Indemnify and save harmless the Intermountain Conservation District, their agents, engineer servant and/or employees from any liability that may result from the use of this equipment or service.
